(1) Options were granted to the reporting person in consideration of his service as an Executive Officer of the Company. Options were granted at an exercise price equal to the fair market value of the Common Stock on the date of grant.

The Reporting Person holds options to purchase 3,000 shares at \$1.708333 a share which are presently exercisable and expire on 6/16/2005. The Reporting Person holds options to purchase 12,000 shares at \$2.3125 a share which are presently exercisable and expire on 9/10/2006. The Reporting Person holds options to purchase 8,200 shares at \$7.98 a share of which 4,100 shares are presently exercisable and 2,050 shares each become exercisable on 11/26/2004 and 11/26/2005.
